

Town Board Meeting
Wednesday, May 10, 2023

Present: Chairman Iverson, Supervisors Ahlvin and Gilbertson, Clerk Gunderson and 4 others.
Treasurer Mottram was absent.

Meeting was called to order by Chairman Iverson at 7:00 p.m. Minutes of April 12th read. Motion Ahlvin/Gilbertson to approve. Carried. Financial Report – Motion Gilbertson/Ahlvin to approve. Carried.

OLD BUSINESS: Charging Stations are going up in a parking lot in Ashland. Paul heard from Bill Bailey this morning – not able to get ahold of owner of General Store! This would be their 1st choice for a charging station in Grand View. Put on agenda for next meeting to look for alternative site. Will need three phase electric. We think it would be most visible by the new county building but could certainly go in the Town Hall parking lot as well.

Jack received a letter from Lee Carson regarding Shared Revenues. Lee stated that Assembly Rep. Chanz Green has sponsored a bill to increase our shared revenues. Could increase from \$11,000.00 to around \$50,000.00!

REPORTS: Road Clean Up – Susan felt it went well. Museum – Susan would be willing to sit from 10 – 2 on Saturdays. It need to be cleaned. Board will meet with Mark and take steps to getting it opened.

PUBLIC COMMENTS: Cemetery is being worked on to get it ready for Memorial Day.

NEW BUSINESS: Fireworks will be held on Saturday July 1st. GV Rec. is planning other activities. They are planning other activities. May do a pig roast but will have food for sure. Dale is looking at putting out collection cans in Choppers, El Zarco, Pioneer and the Store.

Diamond Lake – Need to post sign about ordinance. Raye is here for Diamond Lake Association. Steve provided some verbiage that he fills need to be on the sign. Camera & invasive species signs are going up the weekend. They would be willing to look into pricing of sign and have it built. Would like Town to pay for the sign.

Recreation Grants – Walk through with Russ from Cedar Corp. to see what can be done up at the ballpark. May take a year or two to get things lined up grant wise. Want to see what recommendations Cedar Corp. has.

Town Official's Workshop – Paul & Jack went to this on May 8th. Calendar of events seems really useful.

Road Inspection will be Wednesday May 17th starting at 6:00 a.m. at the town garage.

Meeting with Tom Westlund to discuss engineering will be at 9:00 a.m. on Thursday May 18th.
