Question regarding tree removal on hill in park. Done for landscaping purposes. Town cannot have a community tree/yard waste site unless licensed and attendant properly trained.

Schedule for food truck is unknown at this time.

NEW BUSINESS: Community Resources Forum April 18th – Jack will find out what is on the agenda and contact Paul and Dale and make decision about attending.

Summer Road Plan – Projects for town crew were discussed.

Ambulance Services - Going well in Mason. They've hired 2 new people and the building is done. Mason Community Club wants to put up a pavilion on one end of the building.

Solar Plans – Meeting on May 15th and someone from Fire Department should be invited. It will be an overview and a refresher on the process. We have 5 years to finish project.

Road Cleanup – Volunteers to meet at town hall at 4:00 p.m. on April 24th. Trucks will go out to carry adults.

Fireworks – Dale will talk to Jake or Eric and verify when everything is ready to go.

TRID/TRIS Project – Paul reported we were not likely to get grant for work from Pioneer to Old Grade Road.
