## **NEW BUSINESS:**

- Bibon Bridge- Middle pillar needs work. Deck is fine. Quote would be around \$5000 each for the Town of Grand View and the Town of Mason. Town of Mason Approved bridge project last week. Motion Ahlvin/Gilbertson to approve bridge work. Motion carried. Bridge work will begin yet this year.
- Zoning- Kurt Brandt- Garage construction for private use on property that is zoned commercial. Motion Gilbertson/Ahlvin to approve. Motion carried.
- Road Updates- Forestry approved \$150,000 to double chip seal Pioneer Rd from Taylor Lake Rd to Hwy D, approximately 1.3 miles. Will not receive funds until 2027. - Solar Project- Town has agreed to cost share. We are to be reimbursed by tax credit. Paul to contact Bill Bailey and see how we receive that credit.
- Playground- Enbridge check for \$5000 was received. Need to contact Meagan to see where we are at with Bayfield Co. wellness grant.
- Apostle Island Park- Research has shown no one is in favor of the possible switch. Motion Gilbertson/Ahlvin not to pursue at this time. Motion carried.
- WTA Training- Wednesday September 11<sup>th</sup> at 8am, Lakewoods Resort. Chairman, Supervisors and Clerk plan to attend.
- UTV/ATV Use- Motion Gilbertson to not recommend opening Hwy D. Motion died. Motion Ahlvin/Iverson to open Hwy D from Triangle Rd to Camp 8 Rd. Gilbertson opposed. Not unanimous. Motion carried.
