NEW BUSINESS:

- Open Dump Day- Will be held April 25th
- Loader- Used 2021 Loader assessed at \$150,000. Warranty will be out of coverage in May 2026. Can purchase extended warranty for \$2,000 for 2 years of coverage on hydraulics, powertrain, and electronics. Could extend the warranty on this unit or trade and buy new.
- Gravel Crushing- Namakagon is having a company come and crush gravel for them this year. We could hire that company as well. Roughly \$80,000 worth of crushing fees in forest pit and \$90,000 in fees for camp 8 pit.
- Zieles- Motion Gilbertson/Ahlvin to approve spraying on Camp 8 road property.
- Hall Roof- Mark has spoke to someone about getting estimate on roof. Door also needs to have lock looked at. Mark will look at it.
- Forestry Gravel Permit- No action at this time.
- Parking lot posts- Mark to get price on posts for next meeting.
- Dust Control- Price for dust control has gone up. Need to decide what we will do.
- Flowers- Allisah & Vicki will do flowers again. Vicki will buy flowers if the board will reimburse. \$500 budget for this year.
- Dump Truck- Mark is working on getting truck specs together to get quote. Looking to replace in 2027
- County Wide EMS- Meeting tomorrow night.
- Playground Grant- Trying to apply for more grants for highway park. Need to use the 2025 wellness grant up. Lexi to contact the county and see if we can change our plan on money usage to use it for picnic tables, benches and garbage cans and get an extension.
- Shop credit card- Vicki and Lexi will look into this.
