- 20 Mile Creek- Bridge replacement is in the works for 2027. Need to work with them to get the fill.
- Funny’s Bay Landing- Continue to pay for monitor and person to monitor landing and porta potty.
- Speed Limits- Land owner is concerned about speed limit near Atkins Lake and Old Grade. State sets speed limit on all town roads to 55mph. Our town has already lowered them to 45mph. Motion Gilbertson/Ahlvin to reply to land owner and let him know we are looking into it and gathering more information. Motion Carried.
